LEAGUE TO PREVIEW CPC PROPOSALS TO TOWN MEETING

In 2006 Lexington voters adopted the Community Preservation Act, which provided for a three percent surcharge on real estate taxes, to be matched with state monies, to endow a locally controlled fund to be used for open space protection, historic resources, community housing and public recreation projects. Each year the Community Preservation Committee (CPC) reviews proposals for CPA funding and determines which to recommend to Town Meeting for final approval.

At the League of Women Voters First Friday Forum on March 4, Chair Wendy Manz and other members of the CPC committee will discuss the proposals they are recommending for consideration at the 2011 Town Meeting. A few of the CPA proposals to be discussed at the Forum are:

- Battle Green Monument restoration
- Vynebrooke Village drainage work
- A LexHab request for funding to support community housing
- Center playing fields drainage work
- Town of Lexington archives preservation
- Planning funds for community housing on the Leary farm

This is the sixth in a series of 2010-2011 First Friday Forums hosted by the League of Women Voters of Lexington to promote awareness and understanding of public policy issues. Coffee will be available at 9:30 a.m. and presentations will begin at 9:45 in the Community Meeting Room on the lower level of Cary Memorial Library, 1874 Massachusetts Avenue. League Seeks to Stop Efforts to Repeal the Affordable Care Act

Following the U.S. House of Representative's vote to repeal the Affordable Care Act, the League sent a [letter to the Senate](#) urging the body to oppose repeal of the Act. The League's Lobby Corps visited Senate offices this month to reinforce our message. Read our [blog post](#) and [Facebook update](#) on this hot issue. Also, thanks to all of you who responded to our action alert before the House vote! While a majority supported repeal, the margin was closer than expected.

League Fights to Protect Public Financing System

The League fought against the efforts this month to eliminate the public financing system for presidential elections. Although the House voted in favor of repeal, prospects in the Senate are a bit better. The League spoke out by [issuing our letter](#) to the House and [joined a coalition](#), blogging on [our views](#) and urging League members and citizens to [take action](#) in opposing the elimination of this system.

League Urges Senate to Reform Rules

With proposed rules changes being considered in the U.S. Senate, the League [urged members](#) to reform their rules to ensure openness, accountability, decision-making capability and effective performance. In addition to discussing these reforms on [our blog](#), the [League sent a letter to the Senate](#) and joined another with coalition partners urging its members to make transparency and accountability a priority and end needless obstruction that threatens the vibrancy of our democracy. The Senate [agreed](#) to stop “secret holds,” cut down on the number of executive branch appointments that need confirmation, and cut back on post-cloture dithering, while leaders pledged to reduce the use of the filibuster.

Leagues Promotes Fair and Open Redistricting

Leagues in many states are actively promoting transparency and public participation in the upcoming redistricting process. As state leaders undertake the complex and often intensely partisan task of redrawing congressional and state legislative district boundaries, Leagues are hosting public events, preparing testimony, educating the media, engaging key allies and leveraging new technology to ensure districts are drawn in the open and that the public has meaningful opportunities to weigh in. The League believes that open and participatory redistricting will lead to a more representative and accountable democracy and empower communities to advocate for the resources and opportunities they deserve. Voter photo identification bills have been introduced around the country in: Colorado, Connecticut, Iowa, Mississippi, Nebraska, Tennessee, Kansas, Minnesota, Missouri, South Carolina, Texas, Virginia and Wisconsin.
