Most taxpayers are well aware that spending for schools is the largest item in the Town of Lexington's budget. The League of Women Voters of Lexington's First Friday Forum on October 7 will focus on some of the elements that drive the school budget.

Panelists Thomas Plati, Director of Educational Technology & Assessment; Linda Chase, Director of Student Services; and Patrick Goddard, Director of Public Facilities will talk about the importance of their departments and demands on the overall school budget. Barbara Manfredi, former principal of Bridge School, will introduce the panel and moderate the meeting.

This is the first in a series of 2011-2012 First Friday Forums hosted by the League of Women Voters of Lexington to promote awareness and understanding of public policy issues. Coffee will be available at 9:15 a.m. and presentations will begin at 9:30 in the Community Meeting Room on the lower level of Cary Memorial Library, 1874 Massachusetts Avenue. From the League Leaders Update:

Advocacy Report with Updates on the Casino Bill

Senate Bill 150: An Act Relative to an Independent Analysis of Expanded Gaming in the Commonwealth, which was supported with testimony by Louise Haldeman, LWVMA Casino Specialist, was incorporated into the current **House Bill 3711: An Act Establishing Expanded Gaming in the Commonwealth**, opposed by LWVMA, which was passed in the House on September 15. LWVMA President Eva Valentine joined former state Senator Susan Tucker and United to Stop Slots members at a State House rally opposing Class III gambling (slots and table games) on September 13. Vice President and Program and Action Chair Carole Pelchat along with members of the United to Stop Slots coalition, met with Secretary of Housing and Economic Development Gregory Bialecki on September 21 to discuss problems with the current bill and its implementation. The Senate is currently voting on amendments to the bill, which will necessitate a conference committee to resolve.

House Bill 890/ Senate Bill 1650: An Act Updating the Bottle Bill, which adds a deposit to noncarbonated beverages including mineral water, flavored and unflavored water, vitamin water, and other water beverages, tea, sports drinks, isotonic drinks and all other non-alcoholic carbonated and noncarbonated drinks in liquid remain in the Joint Committee on Telecommunications, Utilities, and Energy. A ballot initiative in support of the "Expanded Bottle Bill" developed by the Massachusetts Coalition to Update the Bottle Bill has been put aside, and all efforts will be focused on getting the bill passed and implemented.

House Bill 1469: An Act Relative to Patient Safety requires the development of nurse to patient assignment standards, a patient acuity system and creates support systems to increase and retain nurses, is in the Joint Committee on Public Health, which heard testimony from Judith Deutsch, Health Care Specialist, on September 20.

House Bill 1063/ Senate Bill 190: An Act Relative to Healthy Youth requires each school district or public school that offers sexual health education to provide medically accurate, age-appropriate education, is in the Joint Committee on Education, which received testimony from Terry Yoffie, Education Specialist, on September 20.

Senate Bill 185: An Act Preventing Students from Dropping Out of School, is in the Joint Committee on Education, was accepted for support by the LWVMA Board. On September 27 testimony was given to the Joint Committee by Terry Yoffie, Education Specialist and Jo Corro.

House Passes Sweeping Anti-Clean Air TRAIN Act

Leading Environmental Groups Call on Senate to Reject It, Commend Veto Threat from White House

League Urges Lobbying Disclosure for Members of Deficit Reduction Committee

The League and coalition partners sent a letter to members of the Committee on Deficit Reduction urging them to immediately take steps to voluntarily disclose the efforts of outside interests to lobby them on matters related to the business of the committee.

League Expresses Concern with Delay of Pollution Regulation

The League and coalition groups sent a letter to the White House expressing deep concern that the Environmental Protection Agency will not meet its commitment to propose long- overdue Clean Air Act standards limiting dangerous carbon pollution from new and existing power plants. The groups also asked the President to reaffirm the administration's commitment to issue strong standards that significantly reduce carbon emissions from both new and existing power plants as the Clean Air Act requires.

League Asks House to Promise to Protect Public Health

League President, Elisabeth MacNamara, sent a letter to the House of Representatives asking them to make the promise to protect public health through clean air standards.

League Opposes Cantor Agenda

The League and coalition groups sent a letter to the House of Representatives to oppose the suite of bills contained in House Majority Leader Eric Cantor's legislative agenda memo that would block the Clean Air Act's ability to clean-up life-threatening pollution.
